JUROR:

Shane Guffogg, born in Los Angeles and raised on an exotic bird farm, found his calling as a painter during his youth. A BFA from Cal Arts, an internship with contemporary abstract painter Gary Stephan, and a six-year stint with Pop artist Ed Ruscha prepared him. Guffogg began exhibiting internationally in 1989. His works contemplate the iconography from Ancient to Contemporary cultures, investigating the relationships among their times and peoples, acquiring a metaphoric language where the humble elements and principles of design narrate the visual experience while staging a riotous exploration of our emotions, the human spirit, and the unseen worlds of Quantum Physics and Super String Theory.


Guffogg's 2003 manifesto addressing the current state of painting eventually became the cornerstone for Pharmaka. In the heart of downtown LA's Gallery Row, Pharmaka explores issues in contemporary painting, offering both artists and curators an amicable platform from which to engage the public in the visual dialogue of art. Guffogg is a co-founder and President of this not-for-profit corporation. His involvement with the art community extends to a seat on the Downtown Los Angeles Neighborhood Council, co-chairing the Arts, Aesthetics & Culture committee. He lectures, he curates, and he continues to paint, currently represented by Leslie Sacks Fine Art. The artist makes his home in Hollywood.

All submissions must be sent outputted on $8.5" \times 11"$ paper, one image sheet for each entry or self playing videos. No slide entries will be accepted.

Accepted entries will be notified by email and will be posted on the OCCCA website. CD submissions will not be returned and will be shredded after judging.

A 100 word or less statement, written in first person, should accompany your submission in WORD format. Please use Arial font for ease of conversion for catalog.




Wary of the slick technological elaborations of commercial art, we hunger for the evidence of authentic ideas created by an artist's hand—the ultimate transposer of human intimacy. In doing so, we make an open call for art works rejecting the sleek and the manicured.

Provisional art is a response by the fine art community to the dominancy of commercial art. The 21st century genre is not unlike Dada and Abstract Expressionism, looking to redefine and innovate. Provisional works explore negation. They may be risky, perhaps they collapse beneath the weight of art school dogma, appearing unfinished or tentative, yet reflect the humble beauty of the temporary.

Ultimately, the juried works for OCCCA's proVISIONal Art fly in the face of current art practices, evoking strategies that do not apply to, but rather reply to mainstream conventions.

Open to all mediums, we only ask that you WOW us with your incorruptibility.





Eligibility and Entries

All media and new media will be considered. Artwork, performance, or installations with special instructions or equipment must be described in full and possibly installed by the artist. Special hardware requirements must be included with the accepted entries.

Fees and Deadlines

A non-refundable \$35.00 entry fee must accompany all submissions and arrive at OCCCA by August 28, 2009. This entitles the artist up to three (3) entries. 3-D entries may have up to three views of the work. Include check or money order payable to OCCCA with your entry. All submissions must be sent outputted on 8.5" x 11" paper, one image sheet for each entry or self playing videos. Each image sheet should include in the lower right hand corner: 1) artist name, 2) title of work, 3) medium, 4) year, 5) size (height x width), 6) email address, 7) phone #, and 8) address. No slides or digital files will be accepted unless they are DVD's or Video submissions. All accepted submissions must be re-submitted as high resolution .jpgs or tif files, 300dpi, CMYK on CD, DVD, or self-playing videos. No slide entries will be accepted. The files must be clearly labeled to correspond to your list of submitted works. Refer digital questions to info.occca@gmail.com with Provisional Art in the subject line. Email entries will not be accepted. All non accepted CD submissions will not be returned and will be destroyed after jurying.

Sales

All work will be considered for sale unless otherwise indicated on the entry form. Proceeds from work sold: 65% to the artist, 35% to OCCCA. Checks to the artists are processed within 10 days of the close of the show.

Insurance and Liability

Art sold remains on display until the close of the exhibition. Although care will be taken in handling of entries, OCCCA accepts no responsibility for damage of work submitted to the competition improperly framed or packaged for handling. Artists may wish to obtain their own insurance.

Deadlines for Delivery and Shippings

Accepted work may be hand delivered September 25-27, from Noon to 5 PM. All shipped work must arrive by September 26, at 5 PM to OCCCA at 117 N. Sycamore, Santa Ana, CA92701. Please indicate OCCCA's hours of operation Thursday through Sunday noon to 5 PM to the carrier. Please ship work in sturdy, reusable containers via UPS or Fed-Ex. Make sure to include prepaid shipping label for return (bar coded label purchased at time of your shipment and included inside your shipped box). Unsold entries may be picked up November 15, 2009 from noon to 5 PM. Any work left at OCCCA after November 15, will be subject to a \$5.00 per day storage fee. Any work left at OCCCA for more than one month is subject to sale or disposal without notification.
